# TID Corridors of Opportunity...

• Board Member Beck reported on working with Harrison Township and the City of Harrison on an application for TID funding for the Dry Fork Road project. They are also working on an application for TID funding with Green Township on the North Bend and Westwood Northern Boulevard project, that was previously presented before the HCTID Board. They are looking to apply by Wednesday, March 30, 2022, for this TID funding.

• Bill Shefcik reported on the Notice of Funding Opportunities. There are two funding programs that the WHV would be eligible for: the MEGA and the INFRA. There is just one application that would cover both programs, due in May.

- Board Member Beck commented that he has submitted a letter of support for the City of Cincinnati to submit with their application.
- Tom Arnold commented that ODOT has been contacted as well regarding a letter of support for the City of Cincinnati. He asked that others needing letters of support give them a couple weeks for them to review and return.

### SORTA Update...

- Darryl Haley reported that during the time of COVID, they decided not to lay anyone off and keep running 100% of their service to make sure our community could connect to all the places they needed to connect to. They received an additional \$62.3 million in funding from the ARP Stimulus money for operating. They were also awarded 10.1 million dollars from the FTA for buses which will include zero emissions fleet. They also received notice that they were awarded 3.3 million to update all the bus stops.
- Darryl Haley reported that they will be doing a call for projects for the next round of Infrastructure funding and project applications will be due the end of June. Since the sales tax is coming in higher than expected, they are anticipating more than \$22 million available for projects submitted for the Infrastructure funding.
